National Events are defined as the Parson Russell Terrier National Specialty, Westminster, and the AKC/Eukanuba National Championship.

The Breeder/Owner/Handler Conformation Dog of the Year will be determined based on the number of points accumulated. The dog accumulating the most points over the course of a year will be awarded the title of "PRTAA Breeder/Owner/Handler Conformation Dog of the Year." In the event of a tie, the award will be shared.
